Lake Superior Treatment Center (LSTC) is an Opioid Treatment Program (OTP) located at 14 East Central Entrance, Duluth, MN 55811. At the time of this memo they are serving approximately 210 clients utilizing methadone or buprenorphine. Pursuant to the terms of a settlement agreement, LSTC is expected to close effective September 1, 2015. All clients that will be continuing to receive opioid replacement therapy services will need to be transitioned over to another OTP before that date. If you have clients effected by this closure and will be continuing to fund the placement, please contact one of the other out-patient, public pay OTPs below:
